6. You will pay to our client costs at such amount to be assessed by the Court, if not agreed.

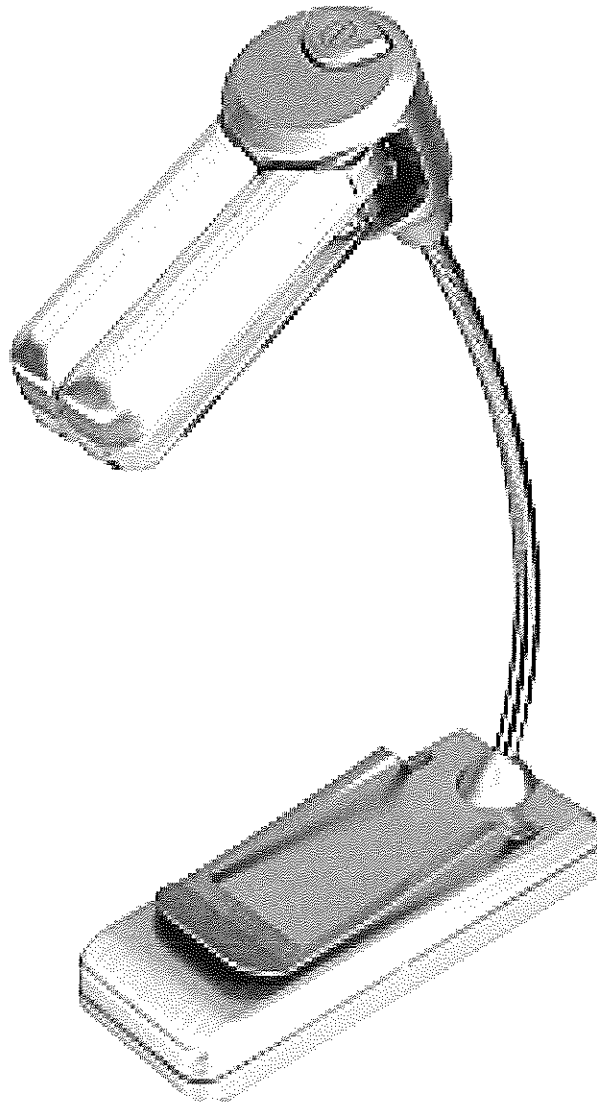
